The National Aquatic Resources Research and Development Agency (NARA) intends to develop a dedicated Fisheries Information Service Mobile Application to provide real-time Potential Fishing Zone (PFZ) advisories, marine weather forecasts, and safety alerts to the fishing community. To ensure a robust, scalable, and procurement-compliant system, NARA seeks to engage a qualified Individual Consultant to prepare the technical specifications, system design documents and procurement-ready materials required to procure the development of the application.
2. The Chairman, Consultants Procurement Committee (PC) on behalf of NARA, now invites eligible Individual Consultants to submit Expressions of Interest (EOI) to provide the following services:
 - Conducting stakeholder consultations and requirement analysis.
 - Developing functional and non-functional requirement specifications.
 - Designing system architecture and API integration frameworks.
 - Preparing comprehensive technical specifications and bidding documents for the procurement of an application development firm.
3. The estimated duration of the assignment is **six (06) weeks** from the date of commencement.
4. Interested consultants must demonstrate that they possess the required qualifications and relevant experience to perform the services. The minimum requirements are:
 - A Bachelor's degree in Computer Science, Information Technology, Software Engineering or a related field (a Master's degree or higher will be an advantage).
 - A minimum of five (05) years of experience in ICT system design or digital platforms.
 - Proven individual experience in mobile application specification and system architecture design.
 - Familiarity with GIS, remote sensing or map-based maritime/environmental information systems is highly desirable.
5. The Individual Consultant will be selected on competition in accordance with the procedures set out in the *Guidelines for Selection and Employment of Consultants (August 2007)* published by the National Procurement Agency (NPA), Sri Lanka.

6. Applicants will be evaluated on their personal qualifications and Experience to carry out the assignment successfully. The detailed evaluation criteria and sub-criteria are given in the Terms of Reference (TOR). The minimum qualifying score is 70 points.
